Support Services Provided to Mission Ahead of APS Launch

USAID/EI Salvador is looking to expand its local partner network in order to broaden the impact of the Mission's new <u>Country Development Cooperation Strategy (CDCS</u>) (available in Spanish and English). The Incubator is providing services to the Mission, including conducting a partner landscape analysis to identify local partners who may have little or no prior experience working with the Agency.

The Mission will soon be launching an <u>Annual Program Statement (APS)</u>. An APS is a call-to-action that describes the need for specific types of programs and then offers funding opportunities that fall within the objectives of the APS through subsequent addenda. USAID/EI Salvador strongly encourages local organizations to prepare for funding opportunities under this mechanism prior to the release of addenda. The Incubator will further support the Mission with the APS launch announcement and will provide information and resources to interested partners through two public webinars and other outreach channels.

Strengthening Science, Technology, Engineering, and Mathematics and Expanding Degree Opportunities

USAID/Malawi seeks to expand the pool of the skilled and employable workforce to spur economic prosperity and self-reliance and enhance resilience to shocks such as drought, famine, floods, and most recently, COVID-19. Specifically, the selected partner organization will design and deliver market linked academic courses and programs, increase access to quality targeted higher education programs (including Science, Technology, Engineering, and Mathematics [STEM] programs), and increase research and innovation outputs. Application deadline is April 26, 2021.

Communities Resilient to Disinformation Building Local Engagement (CREDIBLE)

USAID's Bureau of Latin America and the Caribbean aims to increase digital and media literacy among youth and other target populations, and rebuild the relationship between youth and local communities with local media to strengthen civic culture and inform political processes. The selected organization will partner with USAID, via the CREDIBLE addendum, to explore innovative approaches to the growing influence of disinformation and erosion of democratic norms in Latin America and the Caribbean. Application deadline is May 3, 2021.

Accelerating Control of the HIV Epidemic in Nigeria (ACE)

USAID's Bureau for Global Health (GH) aims to promote new and underutilized partners to accelerate achievement of HIV epidemic control in Nigeria through the delivery of high impact HIV prevention, care and support services to populations in Nigeria most at risk of acquiring HIV. The selected partner organization will work with USAID/Nigeria to scale up and sustain access to HIV/AIDS prevention and treatment services. Application deadline is May 10, 2021.

USAID/Indonesia seeks to engage locally based new and underutilized partners to expand and amplify the Agency's work through and with higher education. The selected partner organization will provide Indonesian students with essential technical skills, critical thinking, soft skills, experiential learning, and internationally recognized certifications and credentials needed by local and international businesses in a digital age and the digital economy. Application deadline is May 24, 2021.
