STATEMENT OF DUTIES:

The USAID Mission to Ukraine is responsible for the development, implementation and oversight of USAID-funded programs operating throughout Ukraine. USAID development assistance promotes Ukraine's transition to a democratic, prosperous, stable, healthy country united in its European aspirations. The USAID/Ukraine Office of Health manages a large, dynamic portfolio of contracts and cooperative agreements to adapt health services and systems that can deliver quality services despite the ongoing war. USAID has directed implementing partners to support fragile health service delivery systems from collapsing, target outreach services to internally displaced persons (IDPs), reinforce systems to mitigate public health issues of concern, and help to maintain operations of health financing and reform institutions. The core focus of the health assistance is to: 1) restore essential primary health services, especially in areas where services have been disrupted due to conflict; 2) help meet growing war-related health needs, such as mental health and physical rehabilitation; 3) ensure continued availability and access to tuberculosis (TB) and HIV services and improve Ukraine's public health security; and 4) strengthen health system governance, accountability and efficiency.

The Project Management Specialist provides analytical and technical expertise to other bilateral/multilateral agencies, host country government and civil society in developing and implementing policies and programs based on best practices and innovations in public health. The Specialist serves as an Agreement Officer's Representative/Contracting Officer's Representative (AOR/COR) or Activity Manager for selected programs/projects/activities. As an AOR/COR, the Specialist monitors program performance and progress, identifies implementation achievements as well as performance challenges, and initiates appropriate actions in consultation with her/his/their supervisor, other Mission staff, and/or the Deputy and Office Director, as appropriate. The Specialist also has reporting responsibilities for the activities managed and communicates successes and best practices to multiple stakeholders. The Specialist is a key member of the Health Office on one of 3 technical teams and receives technical direction from, and reports to one of 3 technical Team Leads. The Specialist has no formal supervisory responsibility.

MAJOR DUTIES AND RESPONSIBILITIES:

Technical Guidance and Program Planning: 30%

- 1) Provide technical guidance in quality and performance improvement, working with key stakeholders to improve the quality of public health services, by applying evidence-based guidelines, approaches, and tools.
- 2) Through literature review, research and regular communication with local and international stakeholders, stay abreast of emerging developments in the national and global public health landscape, and advise accordingly on how policies, strategies, and technical guidelines can most effectively be incorporated to enable USAID to effectively support and implement health programs.
- 3) Engage in analytical and technical discussions with counterparts in the Ministry of Health, USAID implementing partners and to other national stakeholders to advance USAID and USG strategic objectives related to health activities.
- 4) Work closely with other staff in the Office of Health and across the Mission to optimize opportunities for cross-sectoral integration and leverage resources across different program components.
- 5) Effectively communicate and demonstrate technical expertise in interagency technical working groups to ensure USAID strategic priorities are represented, including participation in routine interagency technical discussions.

Project Management: 30%

- 1. Serve as AOR/COR or Activity Manager for Mission health activities, including reviewing and approving USAID IPs annual work plans, facilitating IP relationships, and coordinating with local stakeholders (e.g., other IPs, cooperating country-government counterparts, non-government organizations, other donors, etc.).
- 2. Carry out technical and financial reviews, monitor progress, identify potential issues, and recommend actions for improvements to achieve performance expectations.
- 3. Ensure IPs follow all relevant USAID regulations and procedures, communicating regularly with IPs regarding USAID rules and regulations as well as their obligations to USAID.
- 4. Take a lead role in the preparation of the strategic and operational planning processes such as the USAID Country Development Cooperation Strategy (CDCS), USAID Operational Plan (OP), and other documents.
- 5. Keep the OH senior managers informed of program implementation progress, results, and issues/problems on a timely basis.
- 6. Participate in the design of project mechanisms and activities for improved health, including drafting and obtaining approval for concept papers, scopes of work, evaluation of proposals/applications, and activity start up.
- 7. Provide on-going technical assistance to USAID local partners to ensure that activities are evidence-based and that services are transparent, equitable, of high quality and responsive to client needs.

Project Monitoring and Evaluation: 20%

1. In collaboration with Monitoring, Evaluation and Learning staff, participate in the development of innovative monitoring and evaluation approaches and tools to support measuring the impact and outcomes of health activities.

- 2. Contribute to data quality assessments to ensure the quality and reliability of program data.
- 3. Participate in site visits to USAID-supported programs to assess the quality of services, meet with beneficiaries, and recommend adjustments to programs/projects/activities as appropriate.
- 4. Participate in field visits to ensure successful activity implementation and ensure that sub-partners (sub-awards and sub-contracts) are given appropriate monitoring and oversight.
- 5. Monitor project activities and make recommendations to resolve implementation obstacles to ensure judicious use of USG funds and effective implementation of health activities.
- 6. Contribute to and participate in activity-related program evaluations to document and scale up proven best practices.

Coordination, Representation and Communication: 20%

- 1. Contribute to annual and mid-term planning and reporting documents including the Congressional Budget Justifications, Technical Notifications, Quarterly, Semi-Annual and Annual Progress Reports, among others.
- 2. Prepare reports and responses to a wide range of requirements including responding to requests for information from the Mission Director, the Embassy, USAID/Washington and Congress.
- 3. Ensure that USAID successes, best practices and approaches are shared widely with partner country officials, private sector, civil society and other donors.
- 4. Represent USAID as needed at designated national, regional, and international meetings that relate to health. Prepare briefing papers, presentations and assist with site preparations for visits by delegations of high-level USG officials.

The contractor is eligible for temporary duty (TDY) travel to the U.S., or to other Missions abroad, to participate in the "Foreign Service National" Fellowship Program, in accordance with USAID policy.

Supervisory Relationship: Job Holder receives technical direction and reports to one of 3 technical team leads.

Supervisory Controls: This position is non-supervisory.

PHYSICAL DEMANDS: The work requested does not involve undue physical demands.

QUALIFICATIONS REQUIRED FOR EFFECTIVE PERFORMANCE:

Education: The position requires at least a B.A. or B.S university degree with studies in Medicine, Public Health, Health, Social Work, International Development, Social or Behavioral Sciences, Epidemiology, Biology, Nursing, Nutrition, or Infectious Disease. Masters preferred.

Work Experience: Minimum of three (3) years of progressively responsible, professional experience in public health, prevention and control programs is required.

Language Proficiency: Level IV (fluent) Speaking/Reading/Writing of English and Ukrainian is required.

EVALUATION AND SELECTION FACTORS:

The Government may award a contract without discussions with offerors in accordance with <u>FAR 52.215-1</u>. The Contracting Officer reserves the right at any point in the evaluation process to establish a competitive range of offerors with whom negotiations will be conducted pursuant to <u>FAR 15.306(c)</u>. In accordance with <u>FAR 52.215-1</u>, if the Contracting Officer determines that the number of offers that would otherwise be in the competitive range exceeds the number at which an efficient competition can be conducted, the Contracting Officer may limit the number of offerors in the competitive range to the greatest number that will permit an efficient competition among the most highly rated offers. The technical evaluation committee may conduct reference checks, including references from individuals who have not been specifically identified by the offeror, and may do so before or after a candidate is interviewed.

Selection Process and Basis of Evaluation: Offerors who meet the minimum education and work experience qualification requirements will be further evaluated through review of the offeror's submitted required documents (see points below) and ranked based on the evaluation and selection factors. A competitive range may be established of the highest-ranked offerors, who may be further evaluated through technical/language tests, interviews, and reference checks to determine the most qualified/highest-ranked offeror. Reference checks may be conducted with individuals not provided by the offeror, and without prior notification to the offeror. Any offeror not receiving satisfactory reference checks will no longer be considered for the position. Negotiations may be conducted with the most qualified/ highest-ranked offeror at the conclusion of evaluations.

40 points – Job Knowledge:

Knowledge of project management principles. A good working knowledge of the institutions, government actors, non-government organizations, and private sector actors whose engagement is necessary to successfully implement development and/or health programs in Ukraine.

60 points – Skills and Abilities:

Strong technical skills in public health, health system reform, and programming. Ability to plan, manage, prioritize, and complete tasks from various sources; teamwork skills, including the ability to work collaboratively in a multicultural, team-based environment under tight deadlines; strong learning agility and the ability to effectively adapt to new or changing situations; and a high level of computer skills, including the ability to design and prepare user-friendly and informative reports, matrices, and slide decks using appropriate computer software
