# Foreign Service Limited Position Opportunity: Health Development Officer, Bureau for Global Health, Office of Infectious Disease, Neglected Tropical Diseases Division (GH/ID/NTD) - FL-0685-03

**Description of Organization:** GH serves as USAID's primary source of technical expertise, leadership, and donor coordination for the health sector, including HIV/AIDS; infectious diseases; maternal and child health and nutrition; family planning and reproductive health; and health systems strengthening and reform. GH is responsible for advancing field-relevant, state-of-the-art research and the transfer of new technologies and approaches to field programs. Through its staff, programs, and country teams, GH provides critical support to USAID Missions and field programs in more than 70 countries.

GH/ID/NTD targets neglected tropical diseases that can be controlled or eliminated through safe and effective treatment. These diseases include: Lymphatic filariasis (elephantiasis), Trachoma, Onchocerciasis (river blindness), Schistosomiasis (Snail Fever), and three types of soil-transmitted helminths (intestinal worms). GH/ID/NTD centrally manages an annual \$114.502 million portfolio that provides support to 26 countries across four programs and coordinates with six pharmaceutical companies to leverage \$3.3 billion in drug donations per year.

**Duties and Responsibilities:** The Health Development Officer will support GH/ID/NTD with management and oversight of the NTD Portfolio. The Health Development Officer is responsible for providing operational, administrative, and technical leadership for NTD activities. The Officer will work with USAID implementing partners and host country governments to manage NTD programs and advance progress towards the control and elimination of neglected tropical diseases. The incumbent will perform the full range of project management functions and may serve as Agreement Officer's Representative (AOR) or Alternate AOR of NTD-supported grants and agreements. The Health Development Officer will receive day-to-day guidance from the NTD Chief and senior AORs, and programmatic and technical input from members of NTD.

As the Health Development Officer, you will:

- Serve as the AOR and/or Alternative AOR for programs and projects awarded through NTD, performing the full range of required management functions, and fulfilling governmental functions;
- Assist NTD leadership team as lead on operational and technical management of NTD, including but not limited to, hiring; program and
  administrative procurement actions; interfacing with different levels of the Agency and external stakeholders; and serving on internal USAID
  activities such as working groups and budget development;
- Represent GH/ID/NTD, USAID, and the United States government (USG) at national and/or international technical and programmatic meetings, within various working groups, the interagency, senior host country officials, other donors, and government officials; and
- Provide financial and programmatic oversight to ensure cooperative agreements and grants achieve anticipated results, are linked to, and
  enhance attainment of GH/ID/NTD and USAID objectives.
