CONTRACT INFORMATION BULLETIN 00-1

The purpose of this Contract Information Bulletin (CIB) is to summarize the CIB system and provide a current listing of CIBs. A listing of CIBs being dropped is also attached for your information. This supersedes CIB 99-1.

CIBs provide information of interest to contracting personnel including (but not limited to) advance notification of changes in acquisition or assistance regulations, reminders, procedures, and general information. Also, at times CIBs are used to implement new requirements temporarily, pending formal amendment of acquisition or assistance regulations.

CIBs are issued under the signature of the Director, Office of Procurement, and are normally prepared by M/OP/P, but CIBs can be written by other offices if the subject is in their area of expertise or special interest. M/OP/P maintains the log of CIBs and assigns all CIB numbers.

CIBs are serially numbered on a calendar year basis (99-1, 99-2, etc.) Normally, the first CIB of the year will provide the current listing.

The lists of the current CIBs and the dropped CIBs are attached. Copies of the current CIBs may be obtained from M/OP/P. They are also located on the A&A Policy Page of the Agency Intranet* and on the Agency's external Internet web site**.
