11. DESCRIPTION OF MODIFICATION:
The purposes of this modification are:

1. To extend the completion date of the award from December 31, 2013 to June 30, 2014 by authorizing a six-month no-cost time extension to enable IOM to complete all remaining activities approved under the CHEF Program;
2. To add IOM's cost share contribution in the amount of \$400,000 to the CHEF program budget to cover the expenses to be incurred above the \$56,957,305 during the extension period and to incorporate additional provision related to Cost Share;
3. To incorporate the budget table which reflects:
 - a. the de-obligation amount of \$110,000 through Mod. # 15,
 - b. the de-obligation amount of \$909,544 through Mod. # 17 from the budget for Education Facilities, and
 - c. the addition of \$909,544 to the budget for Health Facilities through Mod. # 18.
