The purpose of this modification is to:

- (i) extend the period of performance for performance of additional work,
- (ii) reduce the total estimated cost, fixed fee and total obligated amount, and
- (iii) make other changes to Sections B, C, and F.

Specific modifications are as follows:

- (i) 1. SF 1442 Block 11: Delete "1123" and insert "1822" in lieu thereof, i.e., The Contractor shall begin performance within fifteen calendar days and complete it within 1822 calendar days after receiving award.
- 2. SECTION F-DELIVERABLES OR PERFORMANCE, F.1 PERIOD OF PERFORMANCE: Delete "December 31, 2013" and insert "November 30, 2015" in lieu thereof.
- 3. Add the following at the end of section F.1 PERIOD OF PERFORMANCE: "The Period of Performance is extended through November 30, 2015 for work under Sub-component 6.4 Kajaki Unit 2 Construction Technical Support Services only. The contractor is authorized to continue closeout work on all remaining components through February 28, 2014."
